STATEMENT OF WITNESS

Statement of : Susan Lindsey

Age of witness (if over 18 enter "over 18") : over 18

Occupation of witness: Senior Licensing Officer, Sevenoaks District Council

I have been employed as the Senior Licensing Officer with Sevenoaks District Council since 8th June 2020. Prior to this I worked with both Lewes and Eastbourne Council's undertaking duties of a similar nature since 2007. My responsibilities include the administering of applications and the issuing and enforcement of licences for all areas of alcohol and entertainment licensing under the Licensing Act 2003. I make this statement from my own knowledge.

This statement is made following my previous statement dated 30th May 2022 with regard to the Premises 'Ephesus, 57-59 High Street, Sevenoaks'.

On Monday 15th August 2022 I received an email from Nick Chapman the Sevenoaks District Council Environmental Health Manager informing me that he was working out of hours and was called over the weekend (13th / 14th August 2022) by a nearby resident to Ephesus in respect of a noise complaint.

Details of Nick Chapman's visit and findings are outlined in his statement attached at **SDL/01** (with his associated evidence NC1 and NC2).

The Sevenoaks CCTV team emailed Nick Chapman on the morning of Sunday 14th August to confirm that the last group of people left Ephesus at 01:24am on Sunday 14th August and included a statement in their email that at 01:10am CCTV witnessed 2 males snorting class A drugs in Rockdale Road just after leaving the premises. This email is attached as evidence **SDL/02**

I checked the records held on the Sevenoaks District Council Uniform system and noted that Mr Surucu had applied for a Temporary Event Notice covering the premises Ephesus from 00:01am on 13th August to 2am on 14th August for the sale of alcohol, but that this Temporary Event Notice did not include the provision of regulated entertainment. A copy of this Temporary Event Notice is attached **SDL/03**.

The Premises Licence issued for Ephesus does not include regulated entertainment (live and recorded music) although the premises does benefit from deregulation of these activities up to 11pm.

I wrote to Mr Surucu on 15th August (attached as evidence **SDL/04**) to bring to his attention the offence pursuant to Section 136 of the Licensing Act 2003 and to clarify that the 3 further Temporary Event Notices submitted for future weekend dates did not, also, cover the licensable activity of regulated entertainment. This letter was emailed to him (copying in his consultant Lyondale whose email address appears on the Temporary Event Notice).

Upon receipt of this letter, Mr Surucu telephoned me to query its content. During our conversation, Mr Surucu said he believed another local pub was watching his premises and reporting things through. He said his music was background and the sound system was his own personal equipment. I told Mr Surucu that it did not matter who owned the equipment and that I consider 'background music' to be low enough that a conversation can be held within his premises and people heard without the need to raise any voices, and that this is not what the Environmental Health Officer had witnessed over the weekend. I expressed my utter disbelief that Mr Surucu would allow such activities to take place whilst his premises is actively under 'review', and that the matters witnessed over the weekend would be reported through as a further statement to the Licensing Sub-Committee Review Hearing. Mr Surucu stated that he thought this to be a conspiracy, and that it is because he is Turkish. I assured Mr Surucu that this is not the case.

On 15th August I then received a telephone call from a local resident who had video footage of a fight which had occurred around 2am on the morning of Saturday 13th August. I asked her to release the video footage she had taken of the fight which she has done, and she has given permission for this to be released to the Licensing Sub-Committee and Mr Surucu. These pieces of video footage are attached as evidence **SDL/05** to **SDL/15**.

On Tuesday 16th August 2022 Charles [REDACTED] (Sevenoaks District Council Environmental Health Officer) sent me a copy of a letter he had sent to Mr Surucu in relation to the noise complaint received over the weekend. This letter is attached as evidence **SDL/16**, with Mr Surucu's response attached as evidence **SDL/17**.

An email was received from Lyondale Planning Ltd (Mr Surucu's consultant) on 16th August 2022 withdrawing the 3 future weekend Temporary Event Notices (attached as evidence **SDL/18**).

Later, on 16th August 2022, a LATE temporary event notice was submitted to the Authority for 26th August from 11.01am to 28th August at 2am. This temporary event notice included activities: the sale of alcohol, regulated entertainment, and late night refreshment. Both Kent Police and Environmental Health objected to this notice, and as a result of these objections, the 'event' cannot go ahead. As this notice is submitted as a 'late' application, no Hearing is necessary to determine it. A counter-notice to this 'event' was issued and sent to the applicant on 19th August by Sharon Bamborough, Head of Licensing Partnership.

Sevenoaks CCTV control room have provided me with a video disc covering 13th August 2022 2am until 2.30am showing the outside area in front of Ephesus.

This has been submitted as evidence **SDL/19**. Stills from this video evidence are attached as evidence **SDL/20**

This video footage clearly shows the individuals involved in the fight (attached as evidence SDL/05 to SDL/15) were customers from Ephesus. SIA security staff from Ephesus were involved in trying to control this, but were unable to do so and it appears staff were re-called back to the premises at 0221hrs, and the premises shut at 0222hrs, before the fight ended.

I have asked Kent Police if Ephesus telephoned through to report this incident on the night, and was informed that it was a local resident who telephoned it through, not anyone from Ephesus.

On Saturday 13 August 2022, I was working as the duty out of hour's officer for Environmental Health.

At 23:34 I was telephoned by Yvonne [REDACTED] (CCTV Operator) who advised that a complaint has been received about amplified music and noise at Ephesus from a nearby resident. I immediately contacted this resident to discuss the complaint. I agreed to visit the complainants property to assess the intrusiveness of the noise.

At around 00:05 on 14th August 2022 I arrived in Sevenoaks and parked along Sevenoaks High Street in front of Savills within a designated parking bay. From my car I could see approximately 15 persons stood and seated in front of Ephesus. Noise of these 'customers' was audible from where I was parked.

I then visited the complainant. Within the complainants bedroom, bass and 'customer noise' was readily audible. The complainant had their bedroom window open but I considered this typical given the warm weather on the evening of the visit. I witnessed the level of the music periodically rising and falling, such that nature of the music and not just the bass was audible. I assume these incidents were caused by, the front door to Ephesus being opened and closed to allow access and egress of customers.

Within the complainant's bedroom, the bass and noise from customers was sufficiently intrusive so as to prevent or disturb sleep. The complainant stated that noise had been of a similar level on the preceding evening and I was shown some videos which I was advised had been taken at around 02:00 on 13 August 2022 which appeared to show a number of individuals fighting on Sevenoaks High Street in front of Waitrose. The complainant advised that they had contacted the police about this.

At 00:18 I left the complainants property and observed the activities at Ephesus from across the road (in front of Waitrose). At 00:19 I took a photograph of Ephesus which shows the crowd of people stood at the front of the premises (NC1). From this location noise of customers was clearly audible. I noted that when the front door to Ephesus was opened music could be heard from my monitoring location.

At 00:21 I took a short video to demonstrate the activity ongoing at Ephesus (NC2).

I then walked to the rear of Ephesus via Rockdale Road and through the carpark. I was able to confirm that Ephesus was the source of the amplified music. From the side alleyway along the side of the premises I was able to see into the conservatory area and the room beyond. From this location I was able to hear amplified music and see purple lighting within the rear room. I could hear Shania Twain 'That don't impress me much' and again confirm that the amplified music was being generated from within Ephesus.

At approximately 00:30, I witnessed a group of four men attempt to enter Ephesus. They were advised by the doorman that the premises was full and shortly after they left.

At approximately 00:35, I telephoned CCTV and advised that I would shortly be leaving the area. I asked that they monitor the premises and confirm what time it closed.

On Sunday 14 August 2022 at 08:18, I received an email from Yvonne [REDACTED] (CCTV operator) to advised that the premises closed at 01:24.

Ephesus, 57-59 High Street, Sevenoaks

It has been brought to my attention that on Sunday 14th August an authorised Officer of Sevenoaks District Council witnessed the playing of recorded music in the form of a DJ at your premises 'Ephesus, 57-59 High Street, Sevenoaks, until 00:15hrs.

The Temporary Event Notice applied for to cover 00:01hrs on Saturday 13th August to 02:00hrs on Sunday 14th August was for the sale of alcohol only (for consumption on the premises). The application did not request 'regulated entertainment' (which includes the provision of live and recorded music).

You do not have live or recorded music authorised on your Premises Licence (19/01981/LAPRE) issued under the Licensing Act 2003: but you do benefit from de-regulatory legislation which does allow for recorded music and live music to be played between the hours of **8am and 11pm** if certain conditions are met.

Pursuant to section 136 of the Licensing Act 2003 it is an offence to carry on or attempt to carry on a licensable activity on or from any premises other than under and in accordance with an authorisation. A person guilty of this offence is liable to be imprisoned for up to 6 months and/or an unlimited fine

I will be requesting that information in relation to this past weekend's activities be disclosed to the Licensing Sub-Committee at the review hearing for Ephesus.

I note that you have submitted a further 3 Temporary Event Notices for the following dates:

- 20th August - 21st August 2022
- 27th August - 28th August 2022
- 3rd September - 4th September 2022

None of the above Temporary Event Notices include the provision of regulated entertainment, so in the interests of clarity, I am informing you now that any live or recorded music provided under any de-regulatory benefits must cease at 11pm.

Complaint of noise nuisance from amplified music and customer noise at:
Ephesus, 57 - 59 High Street, Sevenoaks

As you may already be aware, the Environmental Health Team received details of a further noise complaint on Saturday 13th August at 23:34 hours.

An officer visited the complainant shortly after midnight and observed excess noise emanating your restaurant during an assessment made from the complainant's property. The bass from amplified music was considered to be intrusive, increasing in level when the front entrance door was opened. Noise from a large group of customers waiting outside the restaurant was also considered to be excessive. My colleague was advised that noise on the preceding evening had been of a similar level.

Prior to leaving, my colleague walked around the restaurant and confirmed that the noise was from your restaurant.

You have already been informed that this information will likely be disclosed to the Licensing Sub-Committee at the review hearing for Ephesus. Please also be aware that Environmental Health Team have now objected to the following TEN applications you have made: 22/02951/LATENL (20th - 21st August), 22/02952/LATEN (27th - 28th August, and 22/02973/LATEN (3rd - 4th September) 2022.

During our meeting on 3rd August 2022 you informed me that all music played at Ephesus is controlled by your Formula Sound noise limiter. This does suggest to me that the level has been set too high and will need to be adjusted downwards.

Going forwards, and subject to the outcome of the review hearing, the Environmental Health Team will have regard to this incident and will be considering what other enforcement action may be necessary to control noise from your premises to acceptable levels.

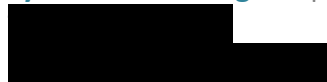
